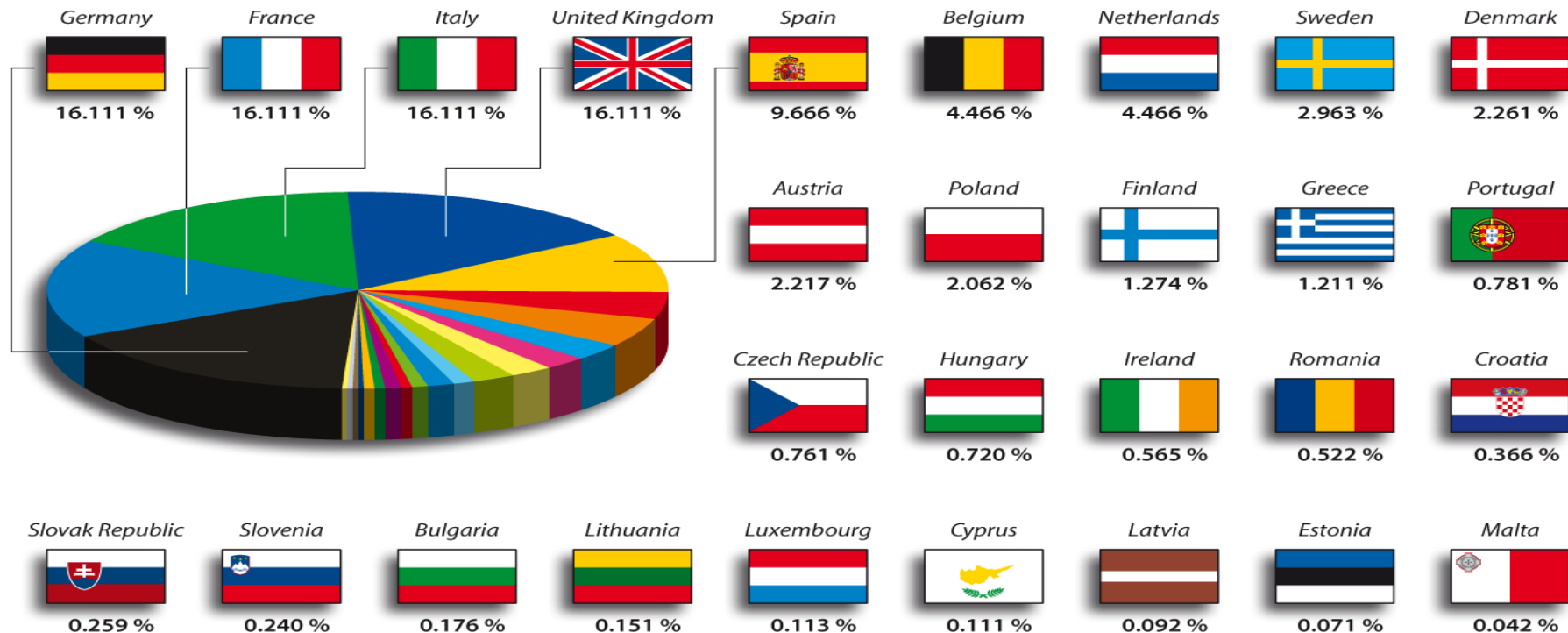
The EIB: the EU bank

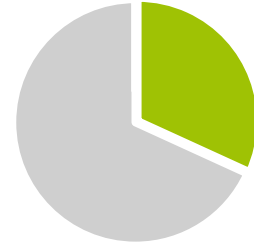

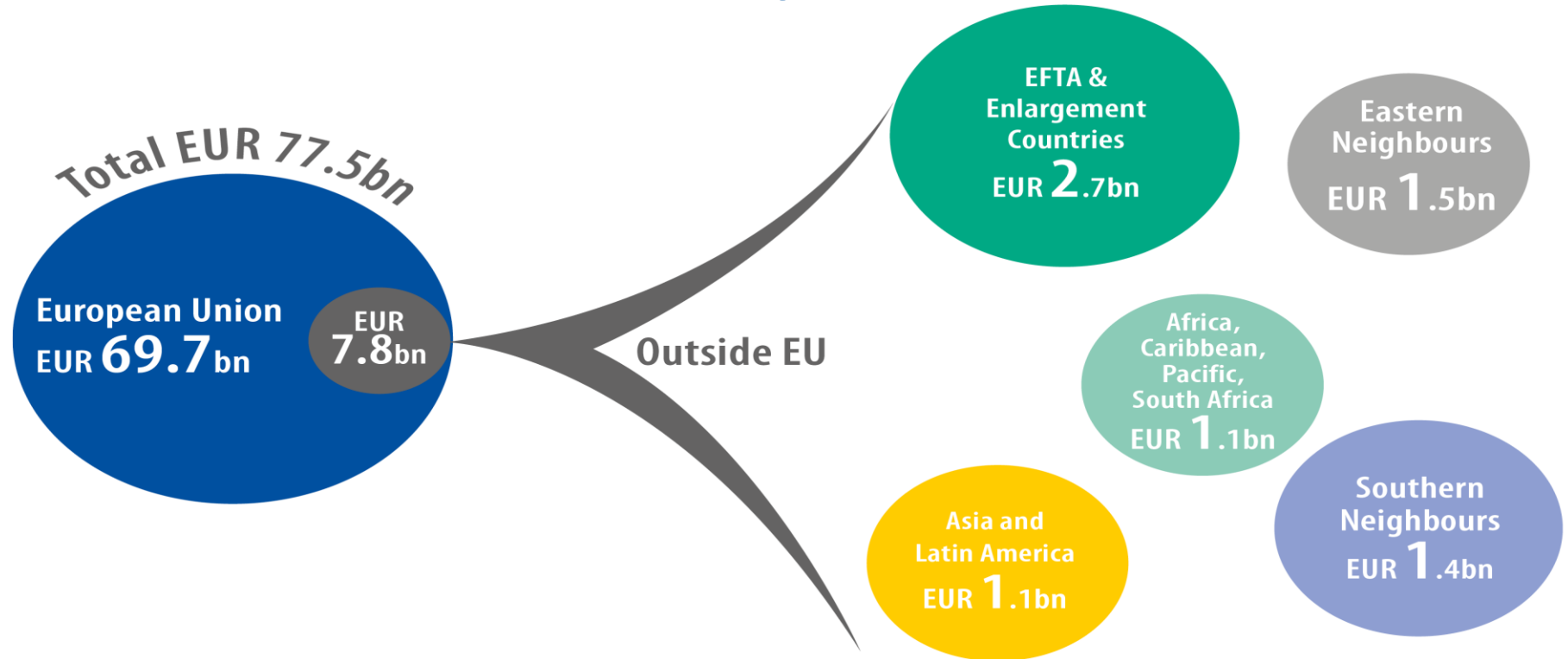

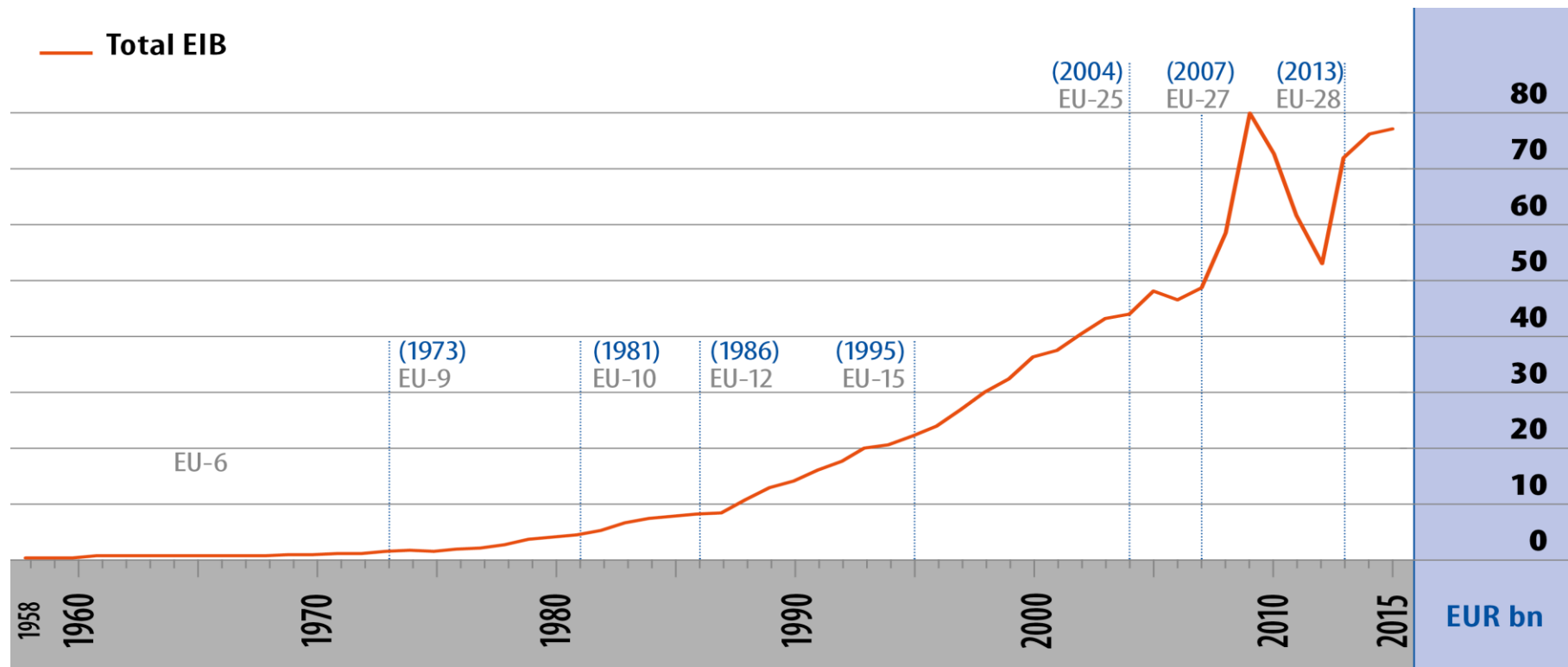

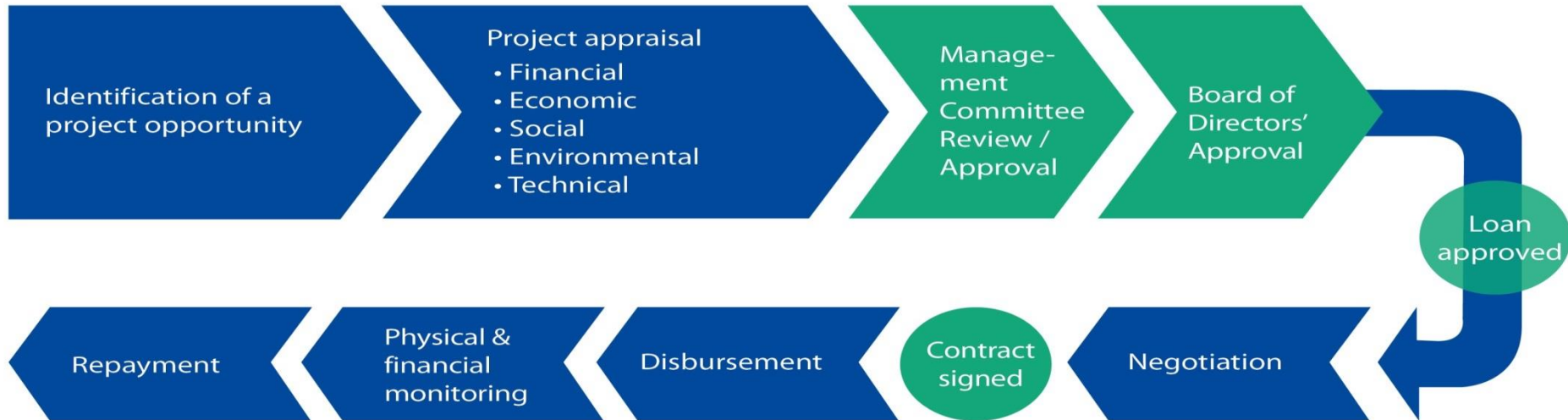

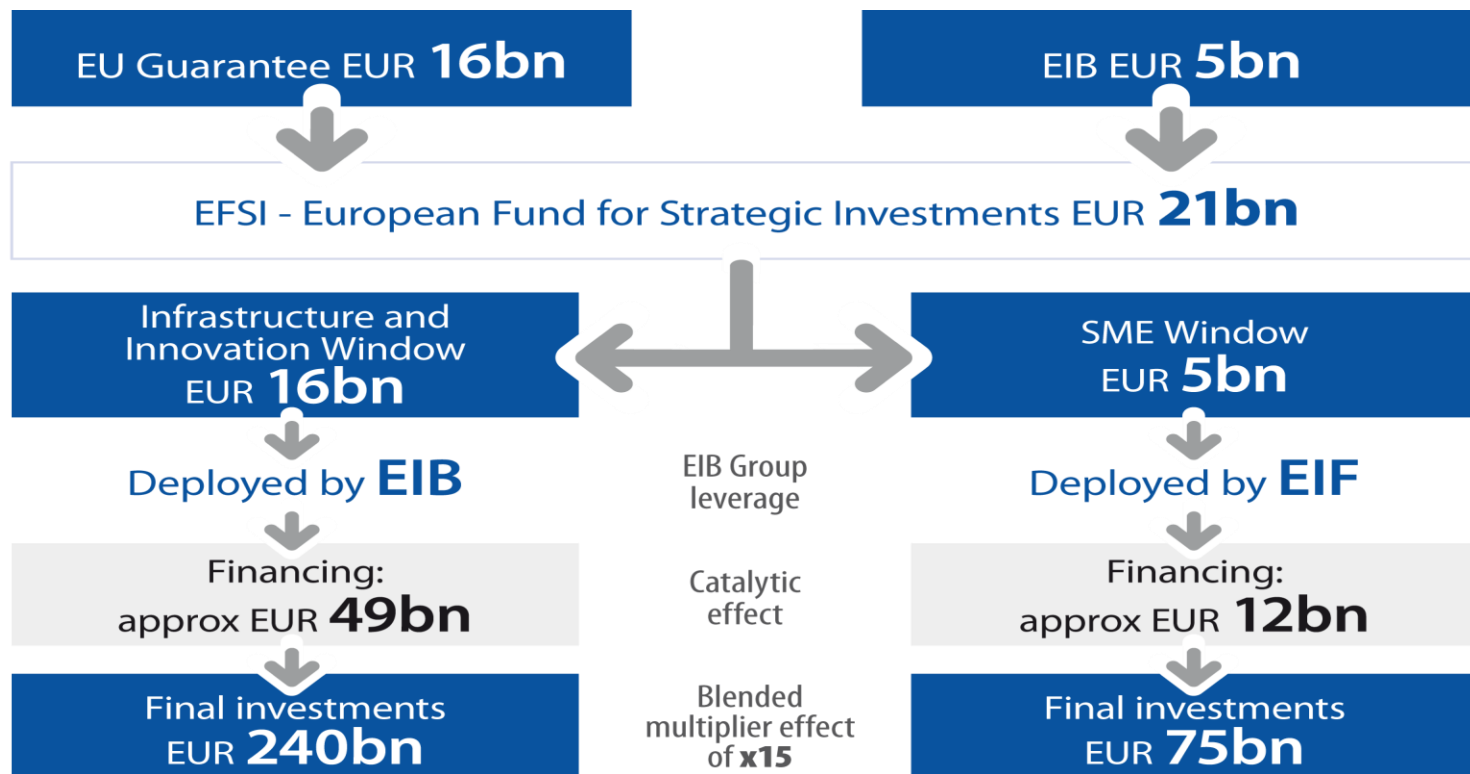

External multiplier

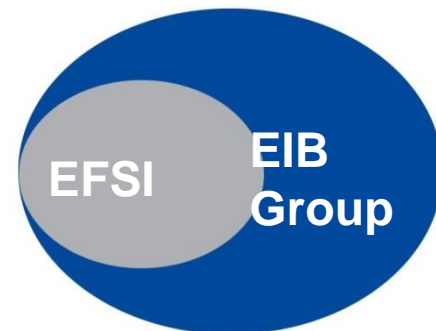
Relation between total investment and EIB financing amount

- EIB & EIF governing bodies approve each operation



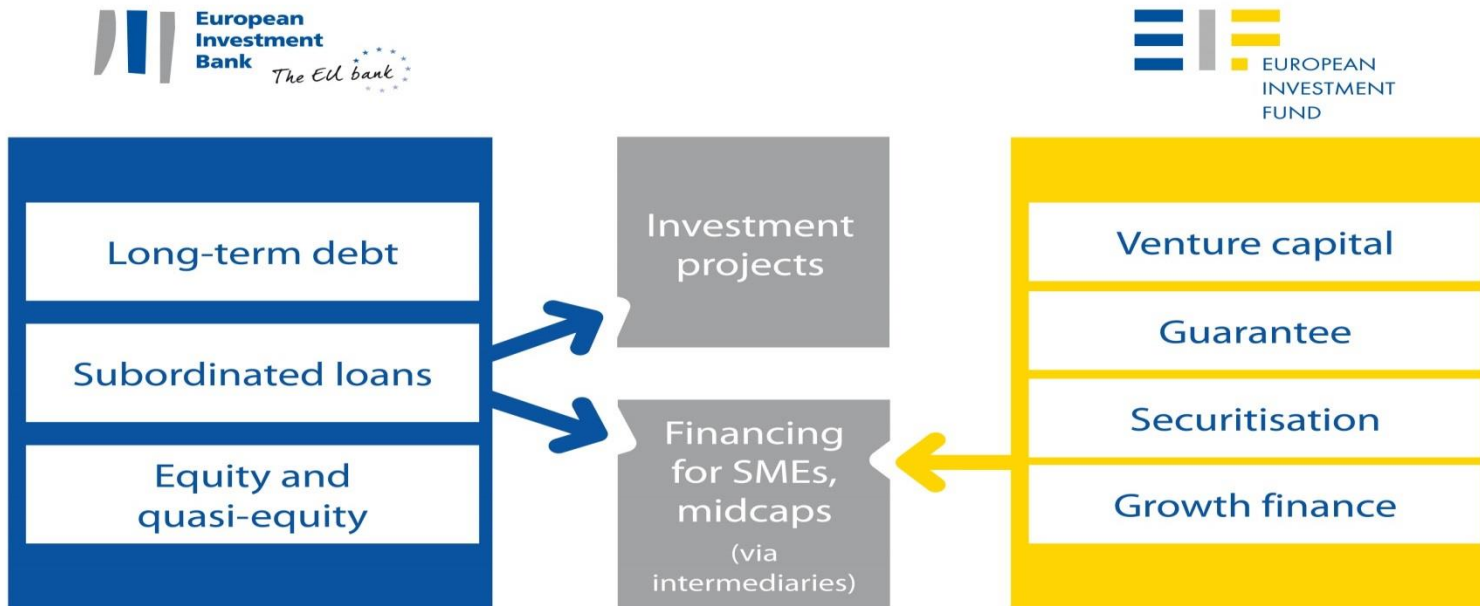
Additional EFSI governance:

- Investment Committee, headed by a Managing Director



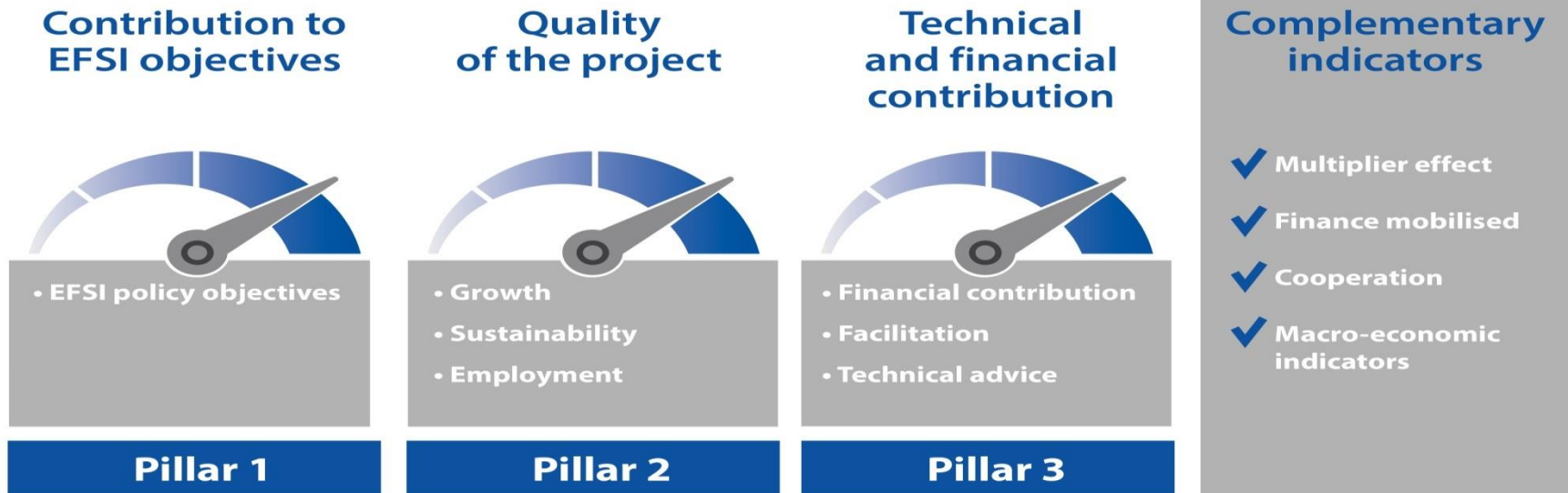
